

Consent on Personal Data processing

I am _____, passport number _____, date of issue _____, hereinafter referred to as 'Personal Data Subject', of my own free will and volition and in my interest in accordance with Federal Law No. 152-FZ dated July 27, 2006 'On Personal Data', I give this consent (hereinafter – 'Consent') to the processing of my personal data by the Federal state autonomous institution of higher education 'Moscow State Institute of International Relations (University) of the Ministry of Foreign Affairs of the Russian Federation' (MGIMO University), situated Moscow, Vernadskogo Avenue, 76 (TIN 7729134728 KPP 772901001) for automated and not automated data processing (including collecting, recording, systematization, accumulation, storage, rectification (updating and modification), extraction, using, transfer (distribution, provision, access), depersonalization, blocking, deletion, erasure) of my personal data, namely:

surname, name, patronymic, date and place of birth; personal photos, photo and video images; sex and citizenship information; addresses of residence; contact details (email, home land line and mobile phone numbers); information about education, graduated specialty and qualifications; passport or other identity documents number and registration data, documents of education and qualifications, the date of their issue with an indication of the authority and / or organization that issued the document; Individual tax number, Insurance individual account number; military registration documents; holding academic degrees, titles; work activities and positions held; information on the availability of state awards; marital status, family members, health status, including information about disability status and other disabilities, participation in the olympiads, competitions and events and its results; information about the concluded and / or paid contract (including the contracts for paid educational services / contract for employer-sponsored education); recommendations or letters of recommendation; international exams results and information about the certificates received, as well as other information and data provided to MGIMO University.

With the purpose of: 1) implementation fulfillment of normative and non-normative legal acts, including orders of the Ministry of Science and Higher Education of the Russian Federation, as well as normative and non-normative legal acts, decisions, requests from public authorities and persons acting on behalf of such public authorities to use my personal data for settlements of the University with me as a student; 2) information and data transfer to the federal information system for ensuring the state final certification of students who have obtained the basic educational programs of basic general and secondary general education, and the admission of citizens to educational organizations for obtaining secondary vocational and higher education, created in accordance with Federal Law of 29 December 2012 "On Education in the Russian Federation" and the Decree of the Government of the Russian Federation of August 31, 2013 No. 755, and / or receiving such information and data from the specified system, or exchanging information and data with it; 3) providing the Personal Data Subject of the information infrastructure, including corporate email accounts and other electronic platforms and services, including with the transfer of personal data to third parties representing platforms and services, making entries in the educational process management system and the accounting and personnel records; 4) accounting attendance and academic performance and determining the reasons that influence them; 5) identification of the Personal Data Subject; 6). implementation of the statutory activities of MGIMO University; 7) collecting and storing information about persons interacting with MGIMO University, and subsequent archival data storage in the data systems of the MGIMO University; 8) military, migration, statistical recording and reporting; 9) posting information about the educational process on the corporate portal of the MGIMO University; 10) receiving the results of proctoring from a third party with whom the MGIMO University will enter into an appropriate agreement, processing the results; 11) posting Personal Data in publicly available university sources (address books, reference books for students, birthdays, etc.) last name, first name, patronymic, photograph, date of birth (day, month); 12) the use of Personal Data for other purposes arising from educational relations.

Grounds for the Personal Data processing: consent of the Personal Data Subject and / or exercise of the legitimate interest of MGIMO University, fulfillment of the agreement concluded with the Personal Data Subject, fulfillment of a legal obligation in relation to MGIMO University. Refusal to provide the above information may makes impossible and / or difficult to receive educational services by the Personal Data Subject. MGIMO University is not entitled to distribute the Personal Data related to the Subject health status to an unlimited number of persons.

The Personal Data Subject has the right to: Receive information about his Personal Data processed by MGIMO University; request clarification of inaccurate or incomplete Personal Data; demand the erasure of Personal Data (in case the purpose of processing Personal Data has been achieved; in case of withdrawal of consent; in case of illegal Personal Data processing or in accordance with the requirements of applicable law); to demand restrictions on the Personal Data processing by MGIMO University (in case of a request for clarification of data or a request to stop processing Personal Data); transfer Personal Data; withdraw this consent at any time in case of violation of the established rules for the processing of Personal Data and in other cases provided for by the Federal Law of July 27, 2006 No. 152-FZ "On Personal Data", by submitting a written statement to MGIMO University indicating the reasons for its withdrawal.

This Consent is valid for a period of 5 (five) years from the date of its signing. In case the Personal Data Subject becomes a student of MGIMO University (recipient of educational services) this Consent is valid during the entire period of study at MGIMO University, as well as for 5 years after graduation or leaving studying process.

I undertake to inform MGIMO University about any changes in my Personal Data and provide proving documents within 7 calendar days from the moment of changing.

I have been warned of responsibility for the accuracy of the Personal Data I have provided to MGIMO University.
